Eligibility to vote

Subject to provisions of section 10 of the Act, the eligibility of a member of trade organization to vote at the elections of the Association shall be subject to following conditions:

- a) The member has completed two years of valid membership of the Association as on date of announcement of election schedule by the Executive Committee of the Association, provided that old members shall be eligible to vote on completion of one year of their enrollment and payment of all dues; and
- b) The member has fulfilled the conditions of membership and renewal thereof under rule 11 of the Trade Organizations Rules 2013

The right to vote shall be allowed only to the authorized representative of the member firm or company.

Appointment of Election Commission

As provided in rule 16, the Executive Committee of the Association has appointed the following on the 3-member Election Commission for conducting Annual Elections 2019-20:

Verification of voters

The voters shall have to produce original CNIC or any other mode of identification for their verification.

Nomination forms for Candidature

The prescribed nomination forms neatly filled in and completed in all respect i.e. duly proposed and seconded by registered voters and signed and stamped in the appropriate columns would be filed with the Secretary General by any person who is eligible to contest the election.

The nomination papers will be issued on request in writing by the authorized representative of the member concerns on its proper letterhead forms.

Elections of Office bearers

The Association shall comprise of a Chairman, Senior Vice Chairman and Vice Chairman, provided that Chairman and Senior Vice Chairman of the Association shall not be from the same province.

Issuance of agenda notice for Annual General Meeting

The proper agenda notice for the Annual General Meeting will be issued and circulated on September 6, 2019.
